Course Description

An introduction to music literature with emphasis on listening experience. Students study the expressive materials of music and the major forms of music literature. Emphasis placed on the skills and understanding necessary for lifelong music listening experiences. (CSU,UC)

I. Objectives:

- **A.** To acquire basic information about music, becoming familiar with the literature of music, its styles, forms, vocabulary, and other aspects that contribute to basic knowledge of the art.
- **B.** To learn to listen intelligently and sensitively by perceiving what is going on in the music.
- **C.** To develop a sensitivity to particular kinds of music.
- **D.** To become familiar with the broad historical survey presented in class, and to concentrate especially on one or two composers representing each style period in music.
- **E.** To develop an awareness of the music opportunities available in the North County Community and to begin to participate as a listener.

II. Concert Attendance & Critique

The student must attend one concert and turn in a concert critique. The concert must be a professional venue The critique should be typewritten and least 3 pages (double-spaced) in length. The concert ticket and program (if any) must be attached to the critique.

III. The "Famous Composer" Class Presentation

Each student will choose a composer who he/she would like to learn about, write a short paper (3 pages minimum, db-spaced, type-written) and give a short presentation in class about the person (10-15 minutes). The composer chosen must be from the assigned period.

IV. Quizzes (5) & Final Exam

A. There will be a short quiz after each major unit of study and students will be told in advance. The quizzes will be made up of multiple choice, true/false and listening questions. They will be

- based on lectures, video presentations and the assigned readings. A Note: A quiz can not be made up due to an absence.
- **B.** The Final Exam will be comprehensive and will be based on assigned readings, lectures and instruction videos. Consequently, it is advised that students take notes during class.

V. Attendance & Participation

10% of the student's grade is based on their 1) participation in class, 2) the number of tardies and 3) their overall attendance. Keep in mind that in a "one- day-a-week" class the student is only allowed 2 unexcused absences at IVC. On the 4th unexcused absence the student will be dropped from the class. If, however, a student has a justifiable reason for being absent and lets the teacher know before the class day, he/she can be excused for that one day.

V. Grading

SLOs: 1) Student will learn and use critical listening skills to analyze the musical form of a work and discuss how timbre and dynamics achieve unity and variety in a given musical composition. 2) Student will learn to identify all the instruments in an orchestra by their appearance and their sound.

3) The student will learn how identify the "form" of a classical or jazz composition through repeated listenings.
