#### **Course Description**

ICS Orientation is intended for personnel assigned to an incident or event that requires a basic understanding of ICS. This course reviews the ICS organization, basic terminology, and common responsibilities. It will provide enough information about the Incident Command System to enable a first responder work in a support role at an incident or event, or to support an incident from an off-site location.

# **Student Learning Outcomes**

After completing this course the students will complete the first six modules of the seventeen modules of the ICS National Training Curriculum that will enable them to participate to work in a support role at an incident or event, or to support an incident from an off-site location.

# **Course Objectives**

At the conclusion of this self-study module, the students will able to do the following:

List the five major organizational activities within the Incident Command System and explain their primary functions; give the titles, and explain the duties of Command and General Staff Members; match organizational units to appropriate Operations, Planning, Logistics, or finance/Administration Sections; match supervisory titles with appropriate levels within the organization; describe the terms used to name major incident facilities, and state the function of each; describe what an Incident Action Plan is and how it is used at an incident; describe how span of control functions within the incident organization and in the use of resources; describe the common responsibilities (general instructions) associated with incident or event assignments and describe several applications for the use of ICS.

#### **Textbooks & Other Resources or Links**

Handouts with the first six modules will be provided on the first day of class. Before starting this class the students will receive the first module (introduction to ICS) by e-mail (pdf) and some instructions.

### **Course Requirements and Instructional Methods**

Perfect attendance and being at class on time is required for successful completion of the course. Participation of the students is required and completing all the assignments. The instructional methods will be PowerPoint Lessons, ICS videos, completing ICS forms, homework and following the standards of conduct.

Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

#### Attendance

- Students are to comply with the following rules of netiquette: (1) identify yourself, (2) include a subject line, (3) avoid sarcasm, (4) respect others' opinions and privacy, (5) acknowledge and return messages promptly, (6) copy with caution, (7) do not spam or junk mail, (8) be concise, (9) use appropriate language, (10) use appropriate emoticons (emotional icons) to help convey meaning, and (11) use appropriate intensifiers to help convey meaning [do not use ALL CAPS or multiple exclamation marks (!!!!)].

# **Academic Honesty**

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- <u>Plagiarism</u> is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. If you do not understand how to "cite a source" correctly, you must ask for help.
- <u>Cheating</u> is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.

Anyone caught cheating or plagiarizing will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file.
