## **Course Description**

An introduction to the concepts of Algebra. Topics covered include solving equations, polynomials, factoring, rational expressions, graphs and linear equations, systems of linear equations, and inequalities. (Nontransferable, nondegreee applicable)

MATH 071 with a grade of "C" or better or appropriate placement.

This outcome will be assessed through selected exercises on exams throughout the semester. (ILO1, ILO2)

#### **Course Objectives**

Upon satisfactory completion of the course, students will be able to:

- 1. demonstrate skills in solving first degree equations.
- 2. demonstrate the ability to solve many problems in diverse areas, in a step-by-step manner, when dealing with applications.
- 3. develop manipulation skills when operating polynomials.
- 4. demonstrate the various types of factoring and be cognizant of the factoring process.
- 5. demonstrate an understanding of skills in operations with and simplifications of rational expressions.
- 6. demonstrate a visual understanding of the Cartesian Coordinate System and linear graphs.
- 7. demonstrate the ability to solve linear systems of equations both algebraically and graphically.
- 8. demonstrate the ability to solve linear inequalities algebraically and be able to present the solutions graphically.

## **Course Requirements and Instructional Methods**

Homework: Homework for the semester is available on the MyMathLab online learning management system. It is expected that you will keep up with the homework. This means that you will complete the homework between class periods. You are also required to keep a homework notebook that will be turned in with your homework on the day of the exam. An example of the expectations of your homework notebook is posted on Canvas.

You may use either:

- Loose leaf notebook paper in a three-ring binder
- Staple each section together and turn in as a bunch
- Spiral Notebook.

This must be very organized or no credit will be given for the notebook portion of your homework grade.

- Quizzes: Quizzes will either be in class or take-home. If I give an in-class quiz, you will have no more than 10 minutes to complete the quiz. You may use your homework notebook.
- Exams: There are five exams. If you can do the homework and the material we discussed in class, you will be prepared for the exam. There are no make-up exams. If you should miss an exam for an emergency, please make sure to get a doctors' note. Generally, I will give a longer, more comprehensive final.
- Office Hours: Take advantage of them. I have office hours after class. I am available most Tuesdays and Thursdays.

Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

# Attendance

- A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. Should readmission be desired, the student's status will be the same as that of any other student who desires to add a class. ## **Classroom Etiquette**

- Electronic Devices: Cell phones and electronic devices *must be turned off and put away during class*, unless otherwise directed by the instructor.

## **Online Netiquette**

- What is netiquette? Netiquette is internet manners, online etiquette, and digital etiquette all rolled into one word. Basically, netiquette is a set of rules for behaving properly online.
- Students are to comply with the following rules of netiquette: (1) identify yourself, (2) include a subject line, (3) avoid sarcasm, (4) respect others' opinions and privacy, (5) acknowledge and return messages promptly, (6) copy with caution, (7) do not spam or junk mail, (8) be concise, (9) use appropriate language, (10) use appropriate emoticons (emotional icons) to help convey meaning, and (11) use appropriate intensifiers to help convey meaning [do not use ALL CAPS or multiple exclamation marks (!!!!)].

#### Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. If you do not understand how to "cite a source" correctly, you must ask for help.
- Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.

Anyone caught cheating or plagiarizing will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file. Repeated acts of cheating may result in an F in the course and/or disciplinary action. Please refer to the General Catalog for more information on academic dishonesty or other misconduct. Acts of cheating include, but are not limited to, the following: (a) plagiarism; (b) copying or

attempting to copy from others during an examination or on an assignment; (c) communicating test information with another person during an examination; (d) allowing others to do an assignment or portion of an assignment; (e) using a commercial term paper service.
