### **Course Requirements and Instructional Methods**

Course Overview: A survey of the developments in art in painting, sculpture, architecture, and the minor arts from the Renaissance to contemporary times. This is a course in visual art appreciation and history for the student with little or no knowledge of art history. The emphasis will be on the so-called plastic arts (painting, works on paper, and sculpture) as well as on architecture. We will cover the stylistic periods in art from before the Renaissance (about 1300 A.D.) to contemporary art. The text and the bulk of the material in the class will be presented in chronological order. The content is strongly based on the required textbook. There are numerous discussions, quizzes, as well as Midterm and Final exams, and an opinion essay. Students are responsible for reading the chapters in the textbook prior to lectures and for a 600-900 word opinion essay.

Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.
