Course Description: A continuation of US 150 (CSU, UC)

<u>Student Learning Outcomes:</u> Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to 1. Demonstrate increasing mastery of vocal techniques; perform a variety of repertoire including but not limited to Spanish, folk, musical theater, classical, and popular music (ILO1, ILO2, and ILO4)

<u>Course Objectives:</u> Upon satisfactory completion of the course, students will be able to: 1. Selfevaluate and be evaluated by the instructor as to beginning placement in study repertoire; 2. Execute proper posture and breathing for singing; 3. Execute proper attacks and releases; 4. Execute the production of free tone; 5. Execute the change of expression through tone color; 6. Execute proper diction for singers; 7. Execute the production of vowels, diphthongs and consonants; 8. Execute legato vocal production; 9. Execute extended range and dynamics; 10. Perform vocal exercises and songs appropriate for the student

<u>Textbooks and References/Supplements:</u> 1. *Expressive Singing,* Vols. I, II, III, IV; 2. Song Anthologies and individual solos selected according to individual needs; 3. Class vocal ensemble singing materials provided by course instructor.

<u>Class Requirements and Instructional Methods:</u> Classes will entail vocal warm-ups, lectures and videos on vocal techniques, the vocal mechanism, vocal performance, and the art of singing. Students (guided by the instructor) will choose vocal solo selections suitable for their voice type, range, and level of proficiency; and will be given guidance on proper vocal execution of the repertoire. It is expected that students will do at least 2 hours of individual practice weekly, outside of class times, on their solo repertoire. Students will be required to perform their solo songs weekly, and will be graded on their progress. *In addition to solo work, students will learn Vocal Class Ensemble selections to be performed in concerts on and off-campus*. Please note that this is a Vocal Performance Class, hence participation in Concerts is important and mandatory. <u>Concert Schedule thus Far:-</u> Sunday March 10th, 2019 at 1:00pm (I.V. Fair, Palm Stage); Solo Concert Performances on Wednesday March 20th, 2019 (class time); Thursday May 2nd, 2019 (IVC EXPO, IVC Campus, TBA); Wednesday May 29th, 2019 (class time); Saturday June 1st, 2019 at 4:00pm (First United Methodist Church, El Centro); and Saturday June 8th, 2019 at 9:00am and 2:00pm at IVC Commencement.

<u>Class Attendance</u>: A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class, will be dropped by the instructor as of the first official meeting of the class. Should readmission be desired, the student's status will be the same as that of any other student who desires to add a class. It is the student's responsibility to drop or officially withdraw from the class. See General catalog for details.

Regular attendance in all classes is expected of all students. A student whose continuous, unexcused absences exceed the number of hours the class is scheduled to meet per week, may be dropped.

Absences attributed to the representation of the college at officially approved events (conferences, contests, and field trips) will be counted as 'excused' absences.

<u>Classroom Etiquette:</u> <u>Electronic Devices</u> – Cell phones and electronic devices must be turned off and put away during class unless otherwise directed by the instructor. <u>Food and Drink</u> – are prohibited in all classrooms. Water bottles with lids/caps are the only exception. <u>Disruptive Students</u> – Students who disrupt or interfere with a class may be sent out of the room and told to meet with the Campus Disciplinary Officer, before returning to continue with coursework. <u>Online Netiquette:</u> What is netiquette? Netiquette is Internet manners, online etiquette, and digital etiquette all rolled into one word. Netiquette is a set of rules for behaving properly online. Students must comply with these rules of netiquette: (1) identify yourself, (2) include a subject line, (3) avoid sarcasm, (4) respect others' opinions and privacy, (5) acknowledge and return messages promptly, (6) copy with caution, (7) do not spam or junk mail, (8) be concise, (9) use appropriate language, (10) use appropriate emoticons (emotional icons) to help convey meaning, and (11) use appropriate intensifiers to help convey meaning (do not use ALL CAPS or multiple exclamation marks (!!!)

<u>Academic Honesty:</u> <u>Plagiarism</u> – is to take and present as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism, and keep it in mind when taking exams, and preparing written materials. If you do not understand how to properly cite a source, you must ask for help. <u>Cheating</u> – is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting

others in using materials, which are prohibited or inappropriate in the context of the academic assignment in question. Anyone caught cheating will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file. Repeated acts of cheating may result in an F in the course, and/or disciplinary action. Please refer to the General School catalog for more information on academic dishonesty or other misconduct.
