<u>Course Description:</u> A study and performance of literature for a small orchestra. Performances in local communities and on-campus are required. Field Trips to other musical events will be included (highly desirable, when funding is available), to help performers develop efficient listening and evaluating practices. Solo and ensemble rehearsals and performances (by participants in this class) will be included. Maximum credit is 4 units. (CSU, UC) *This Class may be taken 4 times!! <u>PREREQUISITES:</u> Participants should have at least a little knowledge of playing some instrument, <u>OR</u>, have a burning desire to learn <u>QUICKLY</u>, an instrument of choice. All skill levels are welcomed in this course (Beginning, Intermediate, Advanced, and "used to play"). This is also a GREAT COURSE FOR REGAINING YOUR SKILLS, if you used to play an instrument, but, stopped for a LONG time! PLEASE TELL YOUR FRIENDS ABOUT THIS COURSE!!

Student Learning Outcomes: Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to 1. Demonstrate knowledge and performance skills by correctly performing assigned parts from varied literature for chamber orchestra/instrumental ensemble in concert; correctly perform assigned music of varied repertoire in class rehearsals; demonstrate proper instrumental techniques appropriate to the style of music being performed; correctly interpret music notation symbols of pitch, dynamics and expression; Recall details about the style, period, and performance practice of the composers and compositions studied in class; and Isolate technical performance problems in rehearsal, and systematically apply standard rehearsal techniques to them. 2. Additionally, please demonstrate professional decorum during public performances on and off-campus (ILO1, ILO2, ILO3, and ILO5)

Course Objectives: Upon satisfactory completion of the course, students will be able to: 1. Exhibit improved technical and musical skill on their instrument(s) [ILO2, ILO3]; 2. Exhibit improved musical skills such as sight-reading, rhythmic accuracy, dynamic accuracy, and intonation [ILO2, ILO3]; 3. Exhibit improved ensemble skills, including following directions, group dynamics, section playing, ensemble playing, and the role of the section leader [ILO1, ILO2, ILO3, ILO4]; 4. Exhibit knowledge of different stylistic performance practices of a Chamber Orchestra/Instrumental Ensemble, for example - Classical music of varied eras, Pop, Jazz, Multi-Cultural Music, Mariachi, and more [ILO4, ILO5]; 5. Exhibit knowledge of the aforementioned musical repertoire studied in class [ILO4, ILO5]; 6. Exhibit music reading and listening skills,

including resources for interpretation of notation and style, historical and cultural context through multiple sources [ILO1, ILO2, ILO4, ILO5]

Talking should be minimized or non-existent during rehearsals and performances. Students will be great team-members of the Instrumental ensemble. Students will gain confidence in themselves as blossoming musical artistes. Please note that this is an Instrumental Music Performance Class, hence participation in Concerts is important and mandatory. <u>Class Attendance</u>: A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class, will be dropped by the instructor as of the first official meeting of the class. Should readmission be desired, the student's status will be the same as that of any other student who desires to add a class.
