Course Description

Techniques used for brief therapy crisis intervention, intake interviewing and referral will be studied and practiced. Special attention will be given to the process of intervention, admitting, and recording of information as it pertains to alcohol and drug abuse clients. Through an experiential format, participants will learn and practice skill in brief therapy, different levels of client communication and intake interviewing.



Course Requirements and Instructional Methods

This course will consist of a combination of lectures, class discussion, assigned readings, videos, individual projects and performance on quizzes and exams.

Group Project Assignment: There will be one (1) group assignment given, worth 50 points. More information about this assignment will be given later.

Agency Interview: Each student will be required to visit an agency and conduct an interview on how that agency handles a crisis. More information about this assignment will be given later.

Exams: Three exams will be given. Exams will consist of multiple choices, written, and true and false. No make-up exams will be given unless you have called me **PRIOR** to the exam and let me know that you will not be able to take the exam. If you contact me prior to the exam, you will have one week to make-up the exam. Each exam will be worth 100 points. A #2 pencil and a scantron to each examination will be provided.

Group work, Class participation and Attendance: At the beginning of each class, attendance will be taken (roll call). Attendance list is passes around in class to keep track of class attendance. If a student arrives late he/she will not be allowed in the class once the check in clearance process is completed. Instructor should be notified if a student is going to be absent. Class participation will be measured by presence, active interest and involvement in discussions, exercises and presentations. No makeup group work missed in class.

Attendance

Academic Honesty
