# **Course Description**

This course will examine principles of cognition focusing on prevailing theories, previous research and current trends in the cognitive sciences. Research findings from Human and animal models will use used as a foundation to explore a wide range of topic including cognitive neuroscience, sensation & perception, learning & memory, attention, knowledge and intelligence, consciousness, problem solving, decision making and psycholinguistics among others. Common methods used to study cognitive processes such as positron emission tomography (PET scan), electroencephalography (EEG) and the polygraph test will also be discussed. (CSU, US)

Define cognition and identify the origins of and major areas within the cognitive sciences and explain the differences and similarities of each major subdivisions.

Describe theories, methods, applications, limitations and implications of research findings from humans and animals from the major subdivisions of cognitive psychology.

Describe how modern techniques in neuroscience have advanced our understanding og the biological basis of cognition.

Describe future direction in cognitive psychology and identify and possible moral and ethical dilemmas that may arise as we learn more about thinking and consciousness.

# **Course Requirements and Instructional Methods**

**Exams**: A total of 4 exams will be given based on textbook readings, lecture materials, and multimedia presentations. Exam format will be multiple choices, please bring a #2 pencil and Scranton from on days of the exam.

**Quizzes**: Quizzes will be given after each lecture. Each quiz will have 5 questions based on your readings from the assigned chapters.

**Thought Paper**: You are to type three, 2-3 page thought papers based on your point of view, your thoughts, opinions, ideas, and concepts regarding Cognitive Psychology. This can come from the course textbooks, class discussions, magazines, internet articles, and/or life experiences, etc. **No late papers will be accepted. APA format** 

Group Project Assignments: More information about this assignment will be given at a later date.

# **Class Participation:**

Attending every class session is expected. Arriving tardy, leaving early or stepping outside during lecture will be noted and count against class participation. Please schedule all appointments outside of class time. At the instructor's direction. A student may be dropped after 3 absences. ### Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source.
