### **Course Description**

Right angle trigonometry and applications, unit circle trigonometry, graphs of trigonometric functions, inverse trigonometric functions, trigonometric identities, solving triangles using the Laws of Sines and Cosines, and polar coordinates. (CSU).

MATH 91 with a minimum grade of C or appropriate placement

This outcome will be assessed through selected exercises on exams throughout the semester. (ILO1, ILO2)

# **Course Objectives**

Upon satisfactory completion of the course, students will be able to:

- 1. Define the six trigonometric functions using right triangle and unit circle definitions.
- 2. Express angles in degrees and radians.
- 3. Graph trigonometric functions, including those involving vertical and horizontal translations.
- 4. Solve triangles using the Law of Sines and Law of Cosines, including ambiguous cases.
- 5. Verify trigonometric identities, including sum and difference formulas, half-angle and power-reducing formulas.

- 6. Define and graph inverse trigonometric functions.
- 7. Solve trigonometric equations.
- 8. Graph polar and equations.
- 9. Solve application problems.

#### **Attendance**

(11) use appropriate intensifiers to help convey meaning [do not use ALL CAPS or multiple exclamation marks (!!!!)].

### **Academic Honesty**

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source.
