#### **Course Description**

A continuation of the study of algebra. Attention will be paid to polynomial and rational functions, Exponential and Logarithmic functions, and Matrix Algebra. Additional topics include systems of equations, Linear Programming, and Analytic geometry. (CSU) (UC credit limited. See a counselor)

Prerequisite: MATH 091 or MATH 098 with C or better or appropriate placement as defined by AB 705

- 6. Understand the theory of Exponential and Logarithmic functions.
- 7. Operate on Matrices.
- 8. Solve and model with Linear Systems of equations using matrix algebra.
- 9. Use Linear Programming in common business and science applications.
- 10. Solve non-linear systems of equations.

#### **Course Requirements and Instructional Methods**

My responsibility is to do my best to be an effective guide, while you are responsible to make a commitment to learning and keeping up with the daily work. <u>Remember mathematics is learned through active participation.</u>

#### On daily basis you need to:

- Use provided lectures and book materials to study the day's topics and take notes as needed.
- Work on the assignments.
- Know and attain the pre-requisite topics learned in previous courses.

#### **Class Rules:**

## **Academic Honesty**

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.
