# **Basic Course Information**

#### **Course Description**

A continuation of MUS 165, private lessons in a chosen performance medium at 4th semester college level. One section meeting per week on campus, in addition to private instruction. As required conditions, the student must: 1. Secure a teacher approved by the College, by the 2<sup>nd</sup> week of classes. 2. Take thirty-minute lessons, or the equivalent per semester. 3. Meet on campus for performances as scheduled; and keep accurate records of lesson attendance, ensemble rehearsals, and personal/individual practice logs. (CSU, UC) 4. Present Applied Solo Repertoire in 2 Applied Music Students' Concerts; and in 1 Small Ensembles Concert; 5. Major Concerts will be Thursday March 26<sup>th</sup>, 2020 (Ensembles); Thursday April 30<sup>th</sup>, 2020 (1<sup>st</sup> Solo); Thursday May 28<sup>th</sup>, 2020 (2<sup>nd</sup> Solo). 6. Perform in Juried Exam (FINAL EXAM) on either Wednesday June 10<sup>th</sup>, 2020, or Thursday June 11<sup>th</sup>, 2020.

### \*\*PLEASE NOTE THAT FALL SPRING 2020 will be the LAST TIME THAT APPLIED MUSIC will be offered in this manner. Please DO YOUR VERY BEST with Solo Repertoire, as this is what you'll need for Auditions to TRANSFER to Universities.

#### **Student Learning Outcomes**

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

- 1. Perform 4th semester college level pieces with correct pitches, rhythms, dynamics, and articulations. (ILO1, ILO2, ILO3, ILO4)
- 2. Play twelve major and minor scales up and down in two octaves. (ILO2)

## **Course Objectives**

Upon satisfactory completion of the course, students will be able to:

- 1. Demonstrate the ability to perform two 4th semester college level pieces with correct pitches.
- 2. Confirm the ability to perform two 4th semester college level pieces with correct rhythms.
- 3. Demonstrate the ability to perform two 4th semester college level pieces with correct dynamics.
- 4. Show the ability to perform two 4th semester -college level pieces with correct articulations.
- 5. Demonstrate the ability to play twelve minor scales up and down in two octaves.
- 6. Present studied Applied Music Repertoire in 3 Concerts As Stated ABOVE.
- 7. All Students will be required to sight-read appropriate level repertoire on Juried Exams
- 8. Fourth Semester Applied Students may be required to present a Full Solo Concert of 30 minutes duration.

# **Course Requirements and Instructional Methods**

Upon satisfactory completion of the course, students will be able to:

1. Establish and refine technical skills requisite for selected performance literature appropriate for low division study.

2. Perform selected literature with accurate intonation, correct rhythm and dynamics, appropriate style and phrasing, and acceptable tone quality.

Self-diagnose technical problems in performance and consult with the private instructor on same.
Prepare and perform before a jury of full-time music faculty and the private instructor Representativ

literature and technical studies prepared during the semester. The final semester of study, the jury is replaced by the presentation of public recital featuring representative works of various contrasting style which shall also be judged by the faculty jury.

Two (2) hours of independent work done out of class per each hour of lecture or class work, or 3 hours lab practicum, or the equivalent per unit is expected.

<u>Out of Class Assignments</u>: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time <u>and</u> two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

**Course Grading Based on Course Objectives** 

The student will prepare and perform before a jury of full-time music faculty and the private instructor representative literature and technical studies prepared during the semester.

Judges will grade the performance based on the 11 aspects of music performance. Also, the 3 Semester Concert Performances will be graded.

#### Attendance

• A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of

an online class will be dropped by the instructor as of the first official meeting of that class.
