Course Description

This course is designed to prepare students to perform tune-up and major service on diesel engines. The practical aspect of this course and a comprehensive overview of all the related systems and components allow the student to achieve the objectives of this course.

Student Learning Outcomes

1. Identify the difference between a tune-up and a major diesel engine service.
2. Describe the safety steps necessary to service a diesel engine and its related systems and components.
3. Describe the steps and procedure to perform diesel engine tune-up service.
4. Remove, replace, test, analyze all the related systems and components of a diesel engine to perform a tune-up service.

Course Objectives

Upon satisfactory completion of the course, students will be able to:

1. Demonstrate knowledge of the history and principles of operation of the diesel engine.
2. List the proper steps for taking a pump and injector apart with proper care.
3. Identify the design and construction of the injector and name the components.
4. Remove, analyze, and replace all the related systems and components of a diesel engine.
5. Install a diesel pump and bleed the system.
6. Diagnose compression problems.
7. Analyze smoke problems and determine the causes.
8. Understand the operation of the fuel system and other related systems and components.
9. Demonstrate knowledge of the engine electrical circuits and electrical system.
10. Explore Carrers in the diesel technology and ASE certifications.

Course Grading Based on Course Objectives

For successful completion of this course students will need to be present for and participate in all lectures and/or discussions and complete all course assignments in a timely manner in addition to completing all homework, reading, quizzes, tests, and evaluations that will be assigned throughout the semester.

- Your final grade will be calculated as an average of the assignments in these three categories:
 - 400 pts. = [40%] Exams + Quizzes (Final 200/ Midterm 100/ Quizzes 100 pts.)
 - 400 pts. = [40%] Shop assignments
 - 200 pts. = [20%] Homework/ Class assignmentsTotal Grade: 1000 pts. = [100%]
- These categories are made up of all assignments, evaluations, tests, quizzes, the comprehensive final exam, and other exercises given throughout the semester.
- Individual assignments, evaluations, tests, quizzes, and other exercises will be based on a scale of zero to 1000 points.

Attendance

- A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. Should readmission be desired, the student’s status will be the same as that of any other student who

desires to add a class. It is the student's responsibility to drop or officially withdraw from the class. See [General Catalog](#) for details.

- Regular attendance in all classes is expected of all students. A student whose continuous, unexcused absences exceed the number of hours the class is scheduled to meet per week may be dropped. Classroom Etiquette

- Safety test must be passed to work in the shop and complete required lab exercise.

- Comply with tool check out policy and return tools clean.
- Do not perform any work on any vehicle outside the assigned task without permission from your instructor.
- Long hair must be kept in a ponytail or tucked away for safety.
- Always be alert and in the best attitude when working in the shop area to avoid accidents.

Faculty and Staff

All work must cease 20 minutes prior to end of class.

Tools must be cleaned and returned to the tool room.

Any broken or missing tools must be reported immediately. Tools are student's responsibility.

- What is netiquette? Netiquette is internet manners, online etiquette, and digital etiquette all rolled into one word. Basically, netiquette is a set of rules for behaving properly online.
