### **Course Description**

This course is intended for students to take concurrently with Math 190. Included will be the review of exponents, operations on polynomial, rational and radical expressions, solving polynomial, rational and radical equations, fundamentals of trigonometric functions. (Non-transferable, nondegree applicable)

## Course Prerequisite(s) and/or Corequisite(s)

Corequisite: MATH 190

This outcome will be assessed through selected exercises on exams throughout the semester. (ILO1, ILO2)

#### **Course Objectives**

Upon satisfactory completion of the course, students will be able to:

- 1. Perform operations on polynomial expressions.
- 2. Perform operations on rational expressions.
- 3. Perform operations on radical expressions.
- 4. Graph linear, quadratic and radical functions.
- 5. Solve linear, quadratic, radical and rational equations.

6. Demonstrate skills in the basic trigonometric concepts, including evaluating trigonometric functions, graphing and fundamental identities.

### **Course Requirements and Instructional Methods**

Material needed: paper, pen, pencil, highlighter, stapler, graphing calculator.

**Course setting:** This course is designed to have you learn facts while gaining an appreciation of the power of Mathematics and getting ready for your future courses in this field. ### Attendance

## Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.
