COURSE DESCRIPTION

An in-depth study of the nature of crime, the measurement and research of crime, the extent of crime, major theories of crime causation, criminal typologies, criminal justice system response to crime, and societal reaction to crime.

COURSE OBJECTIVES (SLO's)

4. Understand the Constitution and its role in the development of our laws and how those laws effect how we deal with crime in our society.
