# **COURSE DESCRIPTION**

The development, function and techniques of patrol; observation skills; development, traffic and preliminary investigative duties, handling complaints and requests for service, public and community relations and basic crime prevention. The mechanics of field interviews, search and arrests, note taking and police report essentials. Familiarization with basic police equipment and handling of community crime incidents.

#### **Chapter Quizzes (60 Points)**

Each quiz (3) is twenty questions worth one point per question.

#### Final Exam (100 Points)

Final exam is 50 questions worth two points per question.

#### **Individual Presentation (50 Points)**

You must make an 8 minute oral presentation on a criminal justice topic of your choosing. You may use powerpoint or any other visual aid if you so desire. You must speak in a loud, clear voice and make eye contact with the class. You may include a short video clip but it will only count for up to 2 minutes of your time.

#### **Grading Criteria:**

Topic & Content = 35 points Time - 4 minutes = 5 points 6 minutes = 10 points 8 minutes = 15 points

#### Individual Presentation Comments (50 Points)

You must write a short paragraph commenting on each of your classmate's individual presentations.

#### **Grading Criteria**

You will earn 10 points <u>per presentation day</u>. You must comment on all presentations made. Presentations will be made on five separate dates.

#### **Textbook Assignments (40 Points)**

You must submit four (4)  $\frac{1}{2}$  page papers with an article on a criminal justice topic attached. Due dates are listed in the syllabus.

#### **Grading Criteria:**

10 points per assignment. Your  $\frac{1}{2}$  page paper will discuss how the article relates to a chapter in the textbook.

#### **Research Paper (50 Points)**

You must submit a typed, three page, double spaced paper on a criminal justice topic of your choosing. The paper must be stapled, typed, 12 font and 1" margins all around. It cannot be the same topic as your individual presentation.

#### **Grading Criteria:**

Topic & Content = 25 points Spelling/Grammar/Punctuation = 15 points Following instructions = 10 points

#### Attendance (150 Points)

I will deduct 10 points per absence. I will deduct 5 points per day that you arrive late or leave early.
