Course Description:

Introduction to the laws, regulations, standards, policies and procedures and early childhood curriculum related to child health safety and nutrition. The key components that ensure physical health, mental health and safety for both children and staff will be identified along with the importance of collaboration with families and health professionals. Focus on integrating the concepts into everyday planning and program development for all children. (CSU)

Student Learning Outcomes:

- 1. Assess strategies to maximize the mental and physical health of children and adults in programs for all children in accordance with culturally, linguistic and developmentally sound practice.
- 2. Identify health, safety, and environmental risks in children's programs.
- 3. Analyze the nutritional needs of children at various ages and evaluate the relationship between healthy development and nutrition.
- 4. Evaluate regulations, standards, policies and procedures related to health, safety, and nutrition in support of young children, teachers and families.
- 5. Distinguish aspects of quality in programs for young children as related to health and safety, acknowledging the value of collaboration with families and community.

Course Objectives and Minimum Standards for a Grade of 'C':

A. Demonstrate effective strategies for evaluating health and safety policies and

procedures.

B. Compare and contrast various methods of collaboration with teachers and families to promote. health and safety in settings for children ages 0-5.

C. Compare and contrast various health assessment tools and policies.

D. Identify environmental health and safety risks for children ages 0-5.

E. Identify symptoms of common communicable diseases and other health conditions

that effect children young children.

F. Identify and discuss common health and safety issues in early childhood settings.

G. Identify characteristics of abuse and neglect and demonstrate knowledge of

mandated child abuse reporting procedures.

H. Differentiate the nutritional needs of various ages of children and plan economical and

nutritional meals and snacks based on the individual needs of children.

I. Write appropriate early childhood curriculum on the topics of health, safety, and

nutrition appropriate for families and all children.

J. Recognize a caregiver's role and responsibility to model good health, safety and

nutrition habits

K. Research current health issues related to children and families.

L. Review laws and regulations (e.g., Title 22, Title 5, Fire Code) supporting health, safety, and nutrition in children's programs.

Methods of Evaluation:

Grades will be based upon class participation, attendance and completion of assignments, pop quizzes, quizzes, and tests throughout the semester. All material presented in the text, study guide, videos, and handouts will be part of the evaluation process.

All assignments should be typed or written legibly in blue or black ik.

No assignments or projects will be accepted late. They are due on the date assigned. Every student has the same chance to prepare for quizzes and tests. If you miss a quiz and have extra time to study, it is unfair to those students

who took the quiz on time. In order to make up a test, quiz or assignment you must show proof for the absence (doctor's note, hospitalization paperwork, etc.) and it must be approved by the instructor. Regardless of the reason for a missed quiz, all missed quizzes and tests must be made up within a week of when your class took that quiz. Make-ups are at my office during my office hours. Please make sure you are here when tests are scheduled. If you are not here for a scheduled test, you will receive no points for the test. A missed assignment or test is considered an "F" and no points will be given. Plan your schedule to allow for ample study time so you will be prepared. There is no penalty for taking a quiz or test *before* the scheduled time.

Grading Policy
