Course Description:

Developing a science curriculum aimed at introducing the young child to physical science, simple chemistry and biological science concepts. Developing a math curriculum introducing number and math concepts. Emphasis is placed on developing an age appropriate science and math curriculum and planning a science environment that is meaningful and exciting for the young child. (Formerly CFCS 122) (CSU)

Upon satisfactory completion of the course student will be able to:

- 1. Develop a science curriculum introducing young children to physical and simple chemistry, and biological science concepts.
- 2. Create and demonstrate science and math activities.
- 3. Develop a math curriculum introducing number and math concepts that are developmentally appropriate for young children.
- 4. Develop math and science areas in a preschool setting.

Student Learning Outcomes:

Upon satisfactory completion of the course student will be able to:

- 1. Identify and create, critique, and refute oral and written arguments
- 2. Identify and create developmentally appropriate science and math curriculum
- 3. Demonstrate knowledge on child centered math science areas.

Methods of Evaluation:

Grades will be based upon class participation, attendance and completion of assignments, pop quizzes, quizzes, and tests throughout the semester. All material presented in the text, study guide, videos, and handouts will be part of the evaluation process.

All assignments should be typed or written legibly in blue or black ink.

No assignments or projects will be accepted late. They are due on the date assigned. Every student has the same chance to prepare for quizzes and tests. If you miss a quiz and have extra time to study, it is unfair to those students who took the quiz on time. In order to make up a test, quiz or assignment you must show proof for the absence (doctor's note, hospitalization paperwork, etc.) and it must be approved by the instructor. Regardless of the reason for a missed quiz, all missed quizzes and tests must be made up within a week of when your class took that quiz. Make-ups are at my office during my office hours.

Please make sure you are here when tests are scheduled. If you are not here for a scheduled test, you will receive no points for the test. A missed assignment or test is considered an "F" and no points will be given. Plan your schedule to allow for ample study time so you will be prepared. There is no penalty for taking a quiz or test *before* the scheduled time.
