## Course Description

The standard course in freshman English. The course seeks to improve the student's ability to understand serious and complex prose and to improve the student's ability to write an exposition that is thoughtful and clear, including the production of a well-documented research paper. (CSU, UC)

### Course Prerequisite(s) and/or Corequisite(s)

- ENGL 009 with a minimum grade of C or better or
- ENGL 010 or ENGL 099 with a grade of "C" or better or
- Appropriate placement

### Student Learning Outcomes

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

- 1. Compose college-level essays that contain clear thesis statements, effective support, and unified organization. (ILO1, ILO2, ILO4)
- 2. Synthesize information from multiple sources to produce a research paper that is formatted and documented according to MLA guidelines. (ILO1, ILO2, ILO4, ILO5)
- 3. Demonstrate an ability to comprehend and interpret a variety of college-level texts, including complex arguments and at least one full-length novel, play, or non-fiction book, without relying on outside sources for assistance. (ILO1, ILO2, ILO3, ILO4)

### **Course Objectives**

Upon satisfactory completion of the course, students will be able to:

- 1. Read, analyze, and interpret a variety of written texts, including one single-author text.
- 2. Identify evidence, tone, purpose, and audience, and fallacies in a variety of written works.
- 3. Demonstrate a thorough understanding of the writing process, from development and drafting to revising and editing.
- 4. Demonstrate a command of varying writing patterns, such as comparison and contrast, definition, and argumentation.

- 5. Demonstrate an understanding of connotative and figurative language while writing for an academic audience.
- 6. Adapt writing strategies to the requirements of the writing situation (e.g., to essay exam or other timed writing, research writing, reflective writing)
- 7. Examine and analyze their own writing and that of other students with a view towards improving the effectiveness of the written work.
- 8. Develop text analysis and interpretation supported by citations, synthesized with the study and application of documentation styles and library skills (including electronic databases) to produce a research paper.
- 9. Demonstrate an understanding of the writing process by writing at least four essays using a variety of rhetorical modes, along with one research paper, composing a total of at least 6,000 words of formal writing. Expository and argumentative papers constitute the bulk of student writing.
- 10. Participate in a number of activities and areas of study as deemed appropriate by the instructor.

### Course Requirements and Instructional Methods

**In-class work/homework:** The focus of the class is the 3 essay writings, but to achieve those finished products, there will be numerous assignments worked on in and out of class to build those essays. These assignments will be varied and writing-based, including short response and draft writings. Additionally, as two of the essays are based on the assigned novels, there will be comprehension checks to determine eligibility for writing the essays themselves.

**Essays:** There are 2 formal essays that will be developed from the assigned novels. Each essay will have several required components, such as a Rough Draft and multiple in/out-of-class reviews..

**Research Essay:** The argumentative research paper will be a multiple component, research-based project, including a modified Annotated Bibliography, essay, and appropriate citation format.

Course Grading Based on Course Objectives

<b>Research Paper</b>	45%
Essay 1	25%

**Essay grades:** In order to write Essays 1 and 2, the corresponding novel must be read. Comprehension checks will be given, and a passing score of 70% minimum achieved in order to remain eligible for full credit on the essay. If the minimum score is not achieved, the highest grade that can be earned <u>on the essay</u> will be a C grade (70-79%).

**Late work:** Any work that is not submitted on time must be discussed with me within the week of the original deadline. Not all assignments are valid for late credit; if an assignment is accepted late, it will be eligible for half credit.

## Attendance

- A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. Should readmission be desired, the student's status will be the same as that of any other student who desires to add a class. ### Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. If you do not understand how to "cite a source" correctly, you must ask for help.
- Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.

Anyone caught cheating or plagiarizing will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file.
