Course Description

This is a beginning course in programming in Visual Basic to prepare programmers and students of closely related occupations for employment in business and industry. Syntax of the Visual Basic language will be emphasized. The course covers program design and logic, program development, and provides hands-on experience in realistic application programming. (CSU, UC)

Attendance
