## **Course Description**

An introduction to the mathematical concepts needed for further study in Algebra. Topics covered will include the real number system, variable expressions, solving equations, measurement and conversions, and geometry. (Nontransferable, non-degree applicable)

#### Course Prerequisite(s) and/or Corequisite(s)

Prerequisite: MATH 61 with C or better or Math placement test.

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

 Demonstrate problem solving strategies by identifying an appropriate method to solve a given problem, correctly set up the problem, perform the appropriate analysis and computation, and share their interpretation of the conclusion or the outcome, using correct grammar or in an oral presentation. This outcome will be assessed through selected exercises on exams throughout the semester. (ILO1, ILO2)

#### **Course Objectives**

Upon satisfactory completion of the course, students will be able to:

- 1. Demonstrate skills in working with real numbers.
- 2. Demonstrate an understanding of variable expressions.
- 3. Demonstrate an understanding of solving equations.
- 4. Demonstrate an understanding of the English and Metric measurement systems in a wide variety of settings.
- 5. Apply relevant formulas in application problems involving a variety of geometric figures.

## **Course Requirements and Instructional Methods**

Material needed: MyMathLab, paper, pen, pencil, highlighter.

**Course setting:** This course is designed to have you learn facts while gaining an appreciation of the power of Mathematics and getting ready for your future courses in this field. My responsibility is to do my best to be an effective guide, while you are responsible to make a commitment to learning and keeping up with the daily work. <u>Remember mathematics is learned through active participation.</u>

#### On daily basis you need to:

- Use provided lectures and book materials to study the day's topics and take notes as needed.
- Work on the assignments.
- Know and attain the pre-requisite topics learned in previous courses.

#### **Class Rules:**

- 1. Late assignment is **not** accepted
- 2. No make-up test will be given
- 3. Bring your binder, pen, pencil, and highlighter to the class every day.
- 4. It is the student's responsibility to drop or officially withdraw from the class.

- 5. It is your responsibility to take notes and make copies of the notes from the days you have been absent.
- 6. Regular attendance in all classes is expected of all students.

**Out of Class Assignments:** The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time <u>and</u> two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

For this class that means approximately 6 hours of studying, working on assignments and reviewing for the tests outside the class time <u>per week.</u>

#### Extra Credit:

1 HW set will be considered extra credit if all 11 sets have been turned in.

After each test, except the final exam, students will be able to retake a similar test and improve their test score by maximum of 15 points on each test. The retest date and time will be announced 2 days before the retest which will be outside of regular class time depending on the room availability time and location will be announced. Students have to make their schedule free for the retest time block and no other opportunities will be given for that purpose, as this is an optional activity and not a mandatory activity.

#### Attendance

- A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. Should readmission be desired, the student's status will be the same as that of any other student who desires to add a class. It is the student's responsibility to drop or officially withdraw from the class. See General Catalog for details.
- Regular attendance in all classes is expected of all students. A student whose continuous, unexcused absences exceed the number of hours the class is scheduled to meet per week may be dropped. For online courses, students who fail to complete required activities for two consecutive weeks may be considered to have excessive absences and may be dropped.
- Absences attributed to the representation of the college at officially approved events (conferences, contests, and field trips) will be counted as 'excused' absences.

## **Classroom Etiquette**

## **Academic Honesty**

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- <u>Plagiarism</u> is taking and presenting as one's own the writings or ideas of others, without citing the source. - <u>Cheating</u> is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.
