Course Description

This course is designed to help students with a disability or multiple disabilities, to understand their computer usage capabilities and to determine, through an instructor evaluation, the appropriate hardware and software. (Nontransferable, AA/AS degree only)

Course Prerequisite(s) and/or Corequisite(s)

A student must be eligible for services and instruction from the Disabled Student Programs and Services through appropriate verification of a primary disability by certificated personnel and be able to benefit from the programs and services offered by the High Tech Center.

Student Learning Outcomes

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

- Identify and utilize the appropriate hardware and software that will enable them to complete their classes successfully. (ILO1, ILO3).
- Students with intellectual disabilities will Log into the High Tech Center to record their hours so that they can receive credit for this course. Instructor will demonstrate the process to the students and they will ask for assistance as needed. By the end of the semester, 100% of the students will be logging into the lab independently or be responsible for requesting assistance from the instructor or lab assistants. (ILO1, ILO3)

Course Objectives

Upon satisfactory completion of the course, students will be able to:

- Demonstrate the ability to complete class assignments utilizing the access devices and /or appropriate software to their individual needs

Course Grading Based on Course Objectives
