Course Description

This course covers basic electrical formulas, conduit bending and installation, raceway and fittings types and applications. Conductor, cable and wiring techniques, as well as conductor ampacity and sizing. Box and raceway sizing. Single, multi-family dwelling, & commercial load service calculations, and electrical test equipment in all lab assignments. Safety and standardized construction industry practices. (Nontransferable, AA/AS degree only)

Recommended course, or course's but not required: EWIR 110, Math 081, Math 091.

Upon successfully completing this course the student will have acquired gainful basic core knowledge needed in understanding; National Fire Protection Association NFPA 70/National Electric Code (NEC) in the following areas:

- *Conductors, cable and wiring techniques: conductor ampacity and sizing, over current protective devices.*
- *Single line diagrams, electrical prints, drawings, and symbols.*
- *Residential & Commercial electrical services: branch circuits, cooking and appliance demand factor and loads,*

Course Requirements and Instructional Methods

Attendance

- A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. If you do not understand how to "cite a source" correctly, you must ask for help.
- Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.
