<u>Course Description:</u> This course applies and develops rhythmic, melodic, and harmonic skills through sight-singing, ear-training, analysis and dictation (CSU, UC)

<u>Course Prerequisite:</u> Students must successfully pass MUS 122, Beginning Musicianship 2, before taking this course.

<u>Student Learning Outcomes:</u> Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to 1. Demonstrate three-part harmonic dictation (ILO2, ILO4); 2. Demonstrate rhythmic dictation including triplet figures, dotted notes and compound meter, and intermediate—level sight-singing skills (ILO2, ILO4)

<u>Course Objectives:</u> Upon satisfactory completion of the course, students will be able to: 1. Demonstrate a knowledge of four-part harmonization using primary and secondary chords in root position and inversions, through sight-singing, keyboard performance, and written analysis; 2. Demonstrate a knowledge of four-part harmonization using dominant-seventh chords and secondary dominants in root position and in all inversions, through sight-singing, keyboard performance and written analysis; 3. Demonstrate a knowledge of modulations to closely related keys through sight-singing, keyboard performance and written analysis; 4. Demonstrate a knowledge of chorale harmonization through sight-singing, keyboard performance, and written analysis; 5. Correctly notate 3-part dictation

<u>Textbooks:</u> 1. *The Oxford Folk Song Sight Singing Series,* Oxford University Press; 2. Other sight-singing materials provided by course instructor.

Class Requirements and Instructional Methods: There will always be homework assignments. Students must research web-links online (type "Ear-Training Exercises" on any of the large search engines), then practice on many of the free ear-training links, as well as sight-singing exercises. Students MUST practice ear-training and sight-singing exercises/skills outside of class meeting times. Class contact time is very limited, thus your success depends on your diligence. All Musicianship classes will have a number of Composition Projects assigned throughout the semester. All will be graded. There will be 3 written ear-training quizzes, as well as sight-singing tests. There will be NO make-up exams, except in documented extenuating circumstances. If a quiz is made-up, it must be done no later than 1 eek following the original date of the quiz. No exceptions!

<u>Class Attendance</u>: A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class, will be dropped by the instructor as of the first official meeting of the class. Students must comply with these rules of netiquette: (1) identify yourself, (2) include a subject line, (3) avoid sarcasm, (4) respect others' opinions and privacy, (5) acknowledge and return messages promptly, (6) copy with caution, (7) do not spam or junk mail, (8) be concise, (9) use appropriate language, (10) use appropriate emoticons (emotional icons) to help convey meaning, and (11) use appropriate intensifiers to help convey meaning (do not use ALL CAPS or multiple exclamation marks (!!!)

<u>Academic Honesty:</u> <u>Plagiarism</u> – is to take and present as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism, and keep it in mind when taking exams, and preparing written materials. If you do not understand how to

properly cite a source, you must ask for help. Cheating – is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials, which are prohibited or inappropriate in the context of the academic assignment in question. Anyone caught cheating will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file. Repeated acts of cheating may result in an F in the course, and/or disciplinary action. Please refer to the General School catalog for more information on academic dishonesty or other misconduct.
