<u>Course Description</u>: This student receives guidance in the performance and appreciation of the various types of solo songs, while acquiring the facilities for good vocal technique. Principles are applied through group and individual singing (CSU, UC)

<u>Student Learning Outcomes:</u> Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to 1. Demonstrate healthy singing techniques conducive to producing a beautiful tone; perform simple vocal literature suitable for voice range and maturity (ILO1, ILO2, ILO4)

<u>Course Objectives:</u> Upon satisfactory completion of the course, students will be able to: 1. Selfevaluate and be evaluated by the instructor as to beginning placement in study repertoire; 2. Execute proper posture and breathing for singing; 3. Execute proper attacks and releases; 4. Execute the production of free tone; 5. Execute the change of expression through tone color; 6. Execute proper diction for singers; 7. Execute the production of vowels, diphthongs and consonants; 8. Execute legato vocal production; 9. Execute extended range and dynamics; 10. Perform vocal exercises and songs appropriate for the student

<u>Textbooks and References/Supplements:</u> 1. *Expressive Singing,* Vols. I, II, III, IV; 2. Song Anthologies and individual solos selected according to individual needs; 3. Class vocal ensemble singing materials provided by course instructor.

<u>Class Requirements and Instructional Methods:</u> Classes will entail vocal warm-ups, lectures and videos on vocal techniques, the vocal mechanism, vocal performance, and the art of singing. Students (guided by the instructor) will choose vocal solo selections suitable for their voice type, range, and level of proficiency; and will be given guidance on proper vocal execution of the repertoire. It is expected that students will do at least 2 hours of individual practice weekly, outside of class times, on their solo repertoire. Students will be required to perform their solo songs weekly, and will be graded on their progress. *In addition to solo work, students will learn Vocal Class Ensemble selections to be performed in concerts on and off-campus.* Please note that this is a Vocal Performance Class, hence participation in Concerts is important and mandatory. <u>Concert Schedule thus far</u>:- Performances at the End of September 2019 (TBA); End of November 2019; and Saturday December 7th, 2019 at 4:00pm (First United Methodist Church, El Centro).

<u>Class Attendance</u>: A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class, will be dropped by the instructor as of the first official meeting of the class. You should understand the concept of plagiarism, and keep it in mind when taking exams, and preparing written materials. If you do not understand how to properly cite a source, you must ask for help. <u>Cheating</u> – is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting

others in using materials, which are prohibited or inappropriate in the context of the academic assignment in question. Anyone caught cheating will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file.
