<u>Course Description</u>: In this course, students will continue to develop, ameliorate skills and technical facilities learned in Intermediate-Early Advanced Level Piano (MUS 240). Emphasis will be placed on late Intermediate and Advanced Piano technique, all major and minor scales of 3 octaves – hands together, all arpeggios of 3 octaves – hands together, late intermediate to advanced level sight-reading skills, more expanded chord progressions – including primary, secondary, 7<sup>th</sup> and 9<sup>th</sup> chords; late intermediate level harmonization and transposition skills; and the performance of late intermediate to advanced level solo and ensemble repertoire. (CSU, UC)

<u>Prerequisite:-</u>Must have taken and passed MUS 240 with a grade of "C" or better; or demonstrate the skills required to test out of MUS 240.

<u>Student Learning Outcomes</u>: Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to 1. Perform late intermediate to advanced level-4 solo and ensemble pieces with correct pitches, rhythms, fingerings, hand position, at a reasonable tempo, with expressions indications observed (ILO1, ILO2, ILO4); 2. Perform all 12 major scales, and 12 harmonic minor scales, with the RH and LH together, up and down 3 octaves (ILO2, ILO4)

<u>Course Objectives:</u> Upon satisfactory completion of the course, students will be able to: 1. Play all 12 major scales, and at least 6 harmonic minor scales with hands together – up and down 3 octaves; 2. Accurately sight-read music of an appropriate skill level at the keyboard; 3. Demonstrate a knowledge of the elements of music – reading pitch, duration, dynamics, tempo, and expression; 4. Accurately transpose appropriate-level melodies and more complex triadic harmonies in 3 different keys; 5. Be able to accurately perform prepared Level 4 Solo and Ensemble repertoire, of contrasting styles, for Concerts and Exams 6. Be able to perform 4-voice chord patterns of primary and secondary Chords in all keys (playing hymns and simple choral pieces will satisfy this requirement) 7. Demonstrate simple keyboard musicianship skills such as after one is given a simple melody, harmonize it by playing appropriate chords in the left hand 8. Be able to sight-read simple accompaniments for vocalists and instrumentalists, with no more than 3 mistakes. 9. Be able to sight-read simple 4-part choral music with no more than 3 mistakes.

<u>Textbooks and References/Supplements:</u> 1. Piano for Adults, Book 2, by Jane, Lisa and Lori Bastien, Newest Edition. Kjos Music Press, ISBN: 13:978-0849773051; 2. Other special Piano Solo works assigned by Instructor, as well as Level-Appropriate Piano Ensemble Selections provided by Instructor; 3. Fun level-appropriate piano selections chosen by students from internet!

Class Requirements and Instructional Methods: Classes will entail short lectures, presentations, demonstrations; and videos on keyboard techniques, and piano performance, as suitable for the students' level of attainment/skill. Solos will be assigned, sight reading material will be given, scales and other technically facilitating materials will be given, as well as keyboard ensemble work. Likewise, the instructor will ensure that students learn and practice the appropriate functional music theory, as it is essential for fine keyboard learning. *Students must* practice solos, ensemble works, scales, technical exercises, functional music theory, and sightreading, supervised AND UNSUPERVISED during class times. It is expected that students will do at least 4 hours of individual practice weekly, outside of class times, on their solos, technique work, scales and ensemble repertoire. Students will be required to perform their solo selections, scales, and ensemble pieces, weekly, and will be graded on their progress. WRITTEN EXAMS (2):- Will be given on the Appropriate Music Theory (Music Writing) for each level of Piano Class. PERFORMANCE EXAMS (2):- Will take the form of 2 FUN Solo and Ensemble Recitals (Mid-Semester and End of Semester). PERFORMANCE QUIZZES(2):- Will take the form of Playing of Assigned Scales and Technical Exercises; as well as Sight-Reading Tests. Solo and Ensemble Concerts:- 1. Thursday October 17<sup>th</sup>, 2019 at 1:10pm; 2. Thursday December 5<sup>th</sup>, 2019 at 1:10pm.

<u>Class Attendance</u>: A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class, will be dropped by the instructor as of the first official meeting of the class.
