Course Description

This course is intended for students to take concurrently with Math 140.

Course Prerequisite(s) and/or Corequisite(s)

Co-requisite: Math 140

Student Learning Outcomes

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

1. Demonstrate problem-solving strategies by identifying an appropriate method to solve a given problem, correctly set up the problem, perform the appropriate analysis and computation, and share their interpretation of the conclusion or the outcome, using correct grammar or in an oral presentation. This outcome will be assessed through selected exercises on exams throughout the semester. (ILO1, ILO2)

Course Objectives

Upon satisfactory completion of the course, students will be able to participate in review activities. These activities might include the review of algebra.

- 1. Demonstrate an understanding of functions and relations
- 2. Demonstrate skills on factoring polynomials
- 3. Demonstrate skills in operations on rational expressions
- 4. Demonstrate skills in operations on radical expressions
- 5. Demonstrate skills in graphing linear equations, including identifying x and y intercepts.
- 6. Demonstrate skills in solving linear and quadratic equations

No textbook is required. The materials will be provided in class or posted in Canvas.

Course Requirements and Instructional Methods

All review activities will be related to the main trigonometry course-Math 140. The material may include the review of the main topics in algebra. Students will be allowed to work in groups and/or independently based on the assigned material. Some activities may be given as take-home assignments. You will need to log into Canvas to access some of the activities.

Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

Attendance

Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the
 source. You should understand the concept of plagiarism and keep it in mind when taking exams and
 preparing written materials. If you do not understand how to "cite a source" correctly, you must ask
 for help.
- Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.

Anyone caught cheating or plagiarizing will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file.
