### **Course Description**

English 201 is the standard second-semester college-level composition course. The prerequisite for this 3- unit class is English 110, "Composition and Reading" (or its equivalent). In English 201, we emphasize critical thinking in reading and writing beyond that achieved in previous English courses. Written argumentation will focus on classical rhetoric and contemporary issues. Students' research skills are enhanced, and the overall purpose of the course is to improve skill with writing at the college level. English 201 is acceptable for credit in both the CSU and UC systems.

# Course Prerequisite(s) and/or Corequisite(s)

ENGL 110 or ENGL 101 with a grade of "C" or better.

# **Student Learning Outcomes**

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

- 1. Interpret appropriately and analyze a written argument for claim, evidence, reasoning, fallacies, and overall effectiveness. (ILO1, ILO2)
- 2. Develop an effective written argument containing a factual claim, providing valid and appropriate evidence, utilizing appropriate reasoning strategies, and avoiding fallacies. (ILO1, ILO2, ILO3)
- 3. Demonstrate command of rules regarding plagiarism and academic ethics. (ILO3)

### **Course Objectives**

Upon satisfactory completion of the course, students will be able to:

- 1. Student will identify the structure of arguments, including the assertions/claims and the proof/support.
- Student will analyze arguments critically, evaluating multiple arguments for validity and soundness, distinguishing fact from judgment and knowledge from opinion, and differentiating relevant from irrelevant support.
- 3. Student will analyze and construct both deductive and inductive arguments.
- 4. Student will write argumentative prose that defines, that analyzes casual relationships, that advocates solutions, that evaluates judgments, and that refutes other arguments.
- 5. Student will identify formal and informal fallacies in language and thought.
- 6. Student will recognize and apply the effects of denotation and connotation; emotive language; and various figures of speech, especially metaphor, within argumentative prose.
- 7. Student will revise written drafts and edit appropriately for an academic audience, observing conventions of coherence, unity, purpose, grammar, mechanics, and documentation.
- 8. Students will write essays and research papers, mostly argumentative and analytical, composing a total of at least 6,000 words of formal writing.

### **Textbooks & Other Resources or Links**

Our main texts for this class are Writing in College: From Competence to Excellence by Amy Guptill (Open SUNY Textbooks 2016), and The Information Literacy User's Guide: An Open, Online Textbook by Allison Hosier et al (Open SUNY Textboks 2014). These are free textbooks, available for download as PDF files or in eBook format. Also, copies will be placed on our Canvas web site, along with other useful free resources. A wealth of free textbooks and support materials are available for students and teachers, commonly referred to as Open Educational Resources (OER). Our class will take full advantage of these free and low-cost resources in order to provide you quality material while saving you a great deal of money in the process.

# **Course Requirements and Instructional Methods**

We will be producing a variety of written products this session, from short response papers to more ambitious research projects. Short response papers will help you generate and develop ideas for more challenging assignments. Argumentative essays will require research and MLA documentation.

<u>Response Papers</u> help students develop ideas that will find their way into more ambitious projects. These activities also provide students with practice in developing their individual writing style. Many of these papers will be written in class, but some will be assigned for homework.

<u>Essays</u> present ideas in a more formal manner appropriate for a college-level academic arena. These projects could also be developed into more ambitious research projects. Some of these projects might be assigned during class time, as well. Others will be submitted through Canvas.

<u>Research Projects</u> provide students opportunities to develop in-depth analyses of important ideas, wherein their critical-thinking skills are exercised and accurate documentation is provided. Much more than essays, these research projects represent sophisticated attempts at argumentation, taking advantage of classic techniques of rhetoric. MLA Style will be used to document all sources, when necessary.

Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

## **Attendance**

- A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. ## **Online Netiquette**

- What is netiquette? Netiquette is internet manners, online etiquette, and digital etiquette all rolled into one word. Basically, netiquette is a set of rules for behaving properly online.
- Students are to comply with the following rules of netiquette: (1) identify yourself, (2) include a subject line, (3) avoid sarcasm, (4) respect others' opinions and privacy, (5) acknowledge and return messages promptly, (6) copy with caution, (7) do not spam or junk mail, (8) be concise, (9) use appropriate language, (10) use appropriate emoticons (emotional icons) to help convey meaning, and (11) use appropriate intensifiers to help convey meaning [do not use ALL CAPS or multiple exclamation marks (!!!!)].

## **Academic Honesty**

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. If you do not understand how to "cite a source" correctly, you must ask for help.
- Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to
  use materials, or assisting others in using materials that are prohibited or inappropriate in the context
  of the academic assignment in question.

Anyone caught cheating or plagiarizing will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file. Repeated acts of cheating may result in an F in the course and/or disciplinary action. Please refer to the General Catalog for more information on academic dishonesty or other misconduct. Acts of cheating include, but are not limited to, the following: (a) plagiarism; (b) copying or attempting to copy from others during an examination or on an assignment; (c) communicating test information with another person during an examination; (d) allowing others to do an assignment or portion of an assignment; (e) using a commercial term paper service.
