Course Requirements and Instructional Methods

Our class will do 1 Concert – Group Singing and Playing Flutophone/Band Instrument for Grading. ****Your End of Semester Concert will be on your Last Class Meeting Day before Finals Week, in IVC Cafeteria (for Class in Room #314), or Room #305**.**
